MEMBERSHIP CONDITIONS

1. Applications: Applications will be reviewed and acted upon in the sole discretion of the Board of Directors of Cliff Realty Corporation (hereinafter "Club").
2. Dues and Fees: The amount of annual dues, initiation fees and other charges shall be determined from time to time by the Club in its sole discretion.
3. Family: Family memberships include the legal husband and wife and the members of their immediate family who are single, reside at home or in school and have not reached their 21st birthday. Also included are long-term partners that meet the criteria established by the Board. Family members under 16 years old may not make tee times unless accompanied by an adult member.
4. Personal Property: The Club shall not be responsible for any loss or damage to any personal property left or stored on the Club premises.
5. Attire: Proper golf attire is required. Men must wear shirts with collars. Women are not required to wear a collared shirt. Shorts must be of walking length. No jeans, athletic shorts or spandex are permitted.
6. Golf Rules: The Club from time to time will publish rules designed to make the course operate efficiently and the round of golf pleasant and enjoyable. Members must comply with these rules.
7. Annual Dues: Annual dues are non-refundable. In the event illness or injury prevents a member from playing a substantial amount of the season, the Club, in its sole discretion, may issue a credit to be applied to the following year's dues.

I/We understand that when we enter the premises of Cape Neddick Country Club, use any of its facilities or play golf on the course, we assume the risks that are inherent in such activities, including but not limited to, being hit by golf balls, golf clubs, and golf carts.
